# May 2017 Constituency Minutes 17/18 – 1C

**MOTION:** To approve the May 2017 Constituency Minutes as sent out.

VOTED: To carry the motion

# Principal's report as presented by Charlotte Green, Grand Rapids Adventist Academy Principal:

- We started the 94 students, currently at 98 students. Ended last year with 120 students. Reasons why the numbers are different from last year: Last graduating class was 13 and in coming Kindergarten class is 3. We had 12 students move to different schools due to family situations, financial situations or transportation issues. We have also gained 12 new students to GRAA.
- Successful field trips/events: grandparent's day, STEM at Andrews University, Fall week of Prayer by Dr. Russell from Andrews University, HS leadership students to Lake Union leadership camp at Au Sable, LIFT for 7-8 graders at Camp Au Sable.
- Anonymous donor gave enough money for blinds to be put in the whole building
- PSAT test is given to 9-11 Grade in preparation for the SAT and ACT test.
- 5-8 grade handed out GLOW tracks to the community this fall.
- Upcoming Events: K-8 grades will be singing at the nursing homes, 7-8 grade will be making coldweather bags to be passed out downtown, continuing high school & elementary to do a Sabbath music performance at a church once a month, high school bible camp at camp Au Sable in January, Teen Bible Camp for 8th grade at Camp Au Sable in February, K-8 bible fair in February, high school mission trip to Kenya in March.

# Scott Evans, Assistant Chair of Finances, presented the end of year Financial Report of June 2017:

- Page 3, C-03, this is the "cash in bank." \$211,463.33
- Page 3, C-83 under "Liabilities," DeVos FLI funds for Churches participating in this program not money that will be used for the school but, it is sitting in our bank. \$34,173.00
- Estimated about \$157,862 of actual use of what is in cash in bank
- pg. 4, Functional activities summary. Total functions, about \$51,553.03 gain
- Finance detail function on pg. 5
- pg. 6, ended the year with a \$3,584 gain.
- pg. 7, Smart Tuition Report

# June 2017 Financial Report 17/18 – 2C

# Nomination of Officers, presented by Pastor Bob Stewart:

- School board has voted and asked Scott Evans to continue to be the Assistant Chair of Finances and Nereida Martinez to continue to be School Board Chairperson. Both would be serving another 3-year term. Both have accepted.
- We have not found someone willing to be Assistant Vice Chair for the GRAA School Board.

# Nomination of Officers 17/18 – 3C

**MOTION:** To approve the board meeting vote of accepting the nomination of Scott Evans to continue to be the Assistant Chair of Finances and Nereida Martinez to continue to be School Board Chairperson for another 3-year term.

## What to do with TEACH Funds:

- School Board has constructed a suggestion to change the term of the TEACH fund and redirect the donations to the TEACH funds to a different purpose. The current funds in TEACH would be directed to a financial aid fund.
- Constituency will revisit TEACH funds vote from the July 18, 2017 Board Meeting minutes later on in tonight's constituency meeting.

# Presentation of 2017-2018 Final Budget presented by Scott Evans, Assistant Chair of Finances:

- Report:
  - Concerns: revenue dropped. Expense per student increased. Loss of \$114,959 is projected on this budget.
  - Positives: utilities are down from last year \$1,841. Conference is covering the loss of the 2015-16 school year of \$45,589. Tuition Rates have stayed the same for the fourth straight year.

## Preliminary Budget Process Discussion presented by Scott Evans, Assistant Chair of Finances:

- Preliminary Budget Process for next year: Request that a motion be made that the Finances Committee will only bring to Constituency a 2018-2019 Preliminary Budget with a \$50,000 or less loss.
- Current process: the process that we have been following for the past 4-5 years is we would start working on the budget in February and finish by the board meeting in April. We cannot start that process any earlier because we cannot attain good data to project returning student numbers before February. Because we have to wait until February/March, the data needed to project student numbers and there is a strong push to keep the labor component the same in hopes of gaining more students.
